Clarification on laser or intense pulsed light facial treatments

Last Friday (24 July), we wrote to you to share the Welsh Government's guidance for close contact / personal care services including those provided by a Class 3b/4 laser or an intense pulsed light (IPL).

Unfortunately, whilst the Welsh Government guidance provided was correct, there was an error in our covering message regarding facial treatments.

The correct position is set out in section 3.2 of the [guidance](#). It strongly advises that facial treatment with a laser or IPL should not be performed, but that it can be offered providing appropriate personal protective equipment (PPE) is available, and where those performing the treatment have been suitably trained in putting on and taking off PPE, as well being trained in standard infection control precautions.
